#### Trustees' Report For the Year Ended 31 December 2018

This report, incorporating the Strategic Report, was approved by the Trustees, in their capacity as company directors, on 29 April 2019 and signed on their behalf by:

The Trustees are delighted to present their report and the audited accounts for the year ended 31 December 2018.

#### **Objectives and Activities**

The Bible Society in Northern Ireland's stated mission is 'to reach everyone with God's Word in a language and medium they can access and afford, so that each person might experience God's purpose for their life.'

#### **Achievements and Performance**

The Society's work is considered under the following headings.

#### 1. Governance and Management

The Board of Trustees for the Bible Society in Northern Ireland met five times during 2018. The Finance Committee of the Board of Trustees met four times, the Governance Committee of the Board of Trustees also met four times.

The Board and staff of the Bible Society in NI met for an afternoon and evening session in September 2018. This allowed for Board training and induction along with a discussion on the new strategy for 2019 – 2021.

After a period of recruitment, three new Trustees joined the Board– Mrs Doris Dugan, Mr James Diffin and Mr Tommy Stewart. We are delighted to have new members of the Board and have already benefited from their skills and experience.

Two long serving members of our Board of Trustees stood down in 2018 – Ms Joy Scott and Ms Anne Taylor. The contributions of both Joy and Anne were noted, and thanks were expressed to them during the Board meeting and at a separate event.

Bible House, which is owned by the Society had a vacancy in our second-floor office when the accountancy firm moved on after many years of occupancy. During the year a new tenant was secured for the second-floor office and have taken up occupancy. In order to secure a new tenant, the Society invested in some refurbishment work in the second floor offices. Our ground floor retail unit was fully occupied by the same commercial trader.

The staff team of the Bible Society in Northern Ireland remains unchanged.

#### 2. Developing our fundraising potential

In 2018 the Bible Society in Northern Ireland continued to attract significant support from a wide range of individuals, groups and churches across Northern Ireland. (2018: £622,299 compared with 2017: £475,907).

Income from the Society's Bible-a-month Partnership has remained at a similar total to 2017. The Bible-a-month calendar was re-designed to a new format which was more cost effective to produce, easier to recycle and has encouraged more people to sign up as a result of how the information is presented.

Three Direct Mail Appeals were sent out in 2018 focusing on Cambodia, Malawi and Lebanon. Income from Direct Mail appeals fell during 2018; with different projects presented to our supporters each year it is difficult to come to any firm conclusions as to the reasons for variations on income.

The Bible Society in Northern Ireland supporters' magazine, 'Word at Work', was produced three times during the year. This is an important tool to share news about activities in Northern Ireland as well as updates on projects around the world. Appeals are included as part of 'Word at Work'. In 2018 these projects were in Egypt, China and Honduras. In 2018 donations from Word at Work remained at a similar level to 2017.

The Greatest Gift, an alternative Christmas present option highlighting specific projects, had a lower income to previous years.

The Society receives generous donations from churches and church groups throughout Northern Ireland; often these gifts are received in response to a specific appeal, as part of that group's giving to mission or as a result of a deputation visit by one of the Society's team.

Other income was received by the Society from Grant Making Trusts.

Support from church denominations continues with support from World Mission Partnership (Methodist Church in Ireland) for projects in Austria, the Gulf States and Togo over a three-year period. Support was received from the Global Mission Department of the Presbyterian Church in Ireland for the Arab Israeli Bible Society. A grant from the World Day of Prayer committee was received for a project in Suriname.

The Society receives rents under lease or licence agreements for occupation of the ground floor retail unit and the second floor offices (second floor unit vacant during 2018 with a new tenant in December 2018)

Legacy income was received in 2018 from individuals who often had supported the work of the Bible Society in Northern Ireland through their lifetime. (2018: £79,852 compared with 2017: £144,200). This income is unpredictable and a real bonus. In 2018 we received the final balance from one estate bringing the total received over several years to over £400,000.

The Society continued to promote 'Bible Twinning' throughout 2018. This encouraged individuals and churches to 'twin' their Bible with a Bible in either China, Cuba or Togo. The response has been very positive with many individuals and groups getting involved – in 2018 almost 1,200 Bibles were twinned. This has enabled the Society to reach a new audience with information.

In 2018 the Society continued to benefit from the generosity of corporate donors who supported our work.

Support was received from individuals and groups who raised funds on our behalf. Some examples of this were concerts, a theatre production as well as our General Secretary running a Half Marathon for a project that she visited in Cambodia in 2017.

In 2018 we developed a new website – <u>www.biblesocietyni.co.uk</u> which not only provides current information on the work it also allows supporters to make financial donations.

#### 3. Achieving the public benefit of the Bible Society in Northern Ireland

The Bible Society in Northern Ireland is one of a small number of grant making / resourcing Bible Societies within the United Bible Societies (Global Fellowship of Bible Societies). Projects are selected from within a database from Bible Societies all over the world; in 2018 support was given to Bible translation, publication and distribution, to literacy work using the Bible as a learning tool and to Bible engagement and advocacy. Care was taken to not only cover the various elements of Bible mission but to also reach across the globe providing support to Africa, Asia, Europe, the Middle East and to South America.

The above list of projects represents around £400,000 (2017: £470,000) worth of financial support to Bible Societies around the world through the International Support Programme of United Bible Societies. In addition to providing financial support the Society generates significant prayer support from across Northern Ireland through printed material in 'Word at Work', Direct Mails and our Bible-a-month calendar as well as fortnightly prayer and news emails. The emails sent by the Society have been streamlined in 2018 to include one each month on the current Bible-a-month project and another one with general Bible Society news from Northern Ireland and around the United Bible Societies Fellowship.

In Northern Ireland work has continued to increase the appreciation and use of the Bible in our own country. The Bible Society in Northern Ireland has provided Bible texts to groups around Northern Ireland and other resources to help people engage with Scripture for themselves. We produced a free Daily Bible Reading Guide and also created a new resource 'STORY' which is a video resource which places Bible characters into a modern day, Northern Irish, context to help engagement with the Bible story in a new and fresh way. STORY was created in partnership with local drama group 'Play it by Ear'.

We have continued to support 'Amazing Journey' (a project of the Baptist Church in Ireland) by supplying Gospel booklets. We partnered again in 2018 with youth agencies from across Northern Ireland producing TIME OUT: Acts, a magazine format of the Book of Acts.

4. Enhancing the Society's profile within the local Christian community and the United Bible Societies Fellowship

A significant amount of time was spent by the team in church speaking engagements. During 2018 there were more than 50 such opportunities with churches and church groups. These are fantastic opportunities to share the work of the Society to a wider audience, increase support and generate an interest in the work beyond the usual audience.

In 2018 the Society welcomed visitors from other Bible Societies to Northern Ireland. Hrayr Jebejian, the General Secretary of the Bible Societies in the Gulf States visited and spent time with the Society's Team and Board, he spoke at a church group and met with the team at World Mission Partnership (Methodist Church in Ireland) who have agreed to support his work for three years.

Dina Katanacho, the General Secretary of the Arab Israeli Bible Society, was a main stage speaker at the Bangor Worldwide Missionary Convention. This was a wonderful opportunity for the audience to hear her story, hear about her work and life. The Society hosted an event for supporters to meet and chat with Dina during the week of the Bangor Worldwide Convention. The Society had a stand in the mission space at the Convention and used this as an opportunity to network with other agencies as well as meet with supporters old and new.

The Society were present with a stand in the 'Missions Area' at New Horizon in 2018. This allowed interaction with other mission agencies as well as opportunities to interact with supporters.

The Overseas Secretary of the Presbyterian Church in Ireland, Rev Uel Marrs, and the President of the Presbyterian Women, Elma Leeburn, visited Lebanon. An opportunity to visit the work of the Bible Society in Lebanon was arranged. The Moderator of the Presbyterian Church in Ireland, Rev Dr Charles McMullen, visited Jordan and again the opportunity to observe and visit Bible Society activity took place. Rev Dr Laurence Graham, former President of the Methodist Church in Ireland along with Rev Billy Davison, current President, visited the Bible Society in Poland during a visit to Warsaw. These opportunities provided good exposure for these church leaders to the international work of Bible Society.

The Society maintains strong links with the main Protestant denominations and annually presents a Bible to the new President of the Methodist Church in Ireland and the new Moderator of the Presbyterian Church in Ireland. The Society also participates in various networks which raises our profile and provide support to the Society team. Bible Society NI are members of MAP (Mission Action Partnership) and AMS (Association of Mission Societies – Church of Ireland).

The Society plays an important role within the United Bible Societies Fellowship, attending regional and global gatherings and participating in strategic planning for the fellowship.

The General Secretary attended the Europe Middle East Affinity Group meeting in Athens with senior colleagues from across the region in January 2018. The 2018 Round Table Exchange took place in Cuba to coincide with the celebrations for the completion of the One Million Bible distribution project there. The General Secretary attended and then spent some time visiting projects in with the Bible Society staff. These events are hugely beneficial for learning and encouragement.

The Bible Societies in the UK have also met to discuss strategy and operational plans on two occasions in 2018. Senior staff from the British and Foreign Bible Society (England and Wales) and the Scottish Bible Society met with the General Secretary and Board of the Society in Belfast for a one day gathering. Operational staff from the three Bible Society's met in London for another one day gathering.

The Society is part of the Resource Mobilisation Group of the United Bible Societies and the General Secretary sits on the Steering Committee of this group. This group gathers the Bible Societies that are the major funders of Bible Society activity together and influences funding strategies for the fellowship in the future.

The Society facilitated the placement of Scriptures around the world on behalf of churches and groups in Northern Ireland in conjunction with colleagues in other Bible Societies.

Sales of Scripture from Bible House remain low; this is still a worthwhile service which provides Scripture in other languages as well as Gospels and pew Bibles in English to churches and groups in Northern Ireland.

#### 5. Complying with best practice in the day-to-day management of the Society

During 2018 the Board of Trustees of the Bible Society in Northern Ireland have continued to comply with best practice in the day to day management of the Society. A process of Board renewal is ongoing with new members recruited and other members stepping down from their positions as Trustees.

All Board Members are provided with monthly and quarterly financial statements which were discussed in depth at the Finance Committee.

The Society has taken steps to ensure compliance with safeguarding issues and concerns in connection with children and vulnerable adults in the course of its work.

Significant work was completed by the staff team in order to comply with General Data Protection Regulations with new policies and procedures put into place. Compliance with GDPR has impacted our database of supporters with lists reduced, we hope that this does not significantly impact our income in 2019 and beyond.

Investment was made into the IT systems and infrastructure of the Society in order to minimise risk and ensure compliance. These changes have allowed the staff team to be more efficient in their day to day work.

A risk register has been completed and agreed by the Board allowing ongoing monitoring of risk within the Society.

Policies outlining the practice of the Society have been drawn up in relation to the Investments and Reserves activity.

#### **Financial Review**

The accounts as presented show a surplus of £106,157 on the Income & Expenditure Account.

During the year, the Society's incoming resources from donations and legacies increased by 13.2% to £702,151 (2017: £620,107) with the total incoming resources increasing overall by 11% to £721,723 (2017: £650,332). Total expenditure decreased by 8.32% to £615,566 (2017: £671,485) resulting in a surplus £106,157 (2017: -£21,153).

#### Reserves

At 31 December 2018 the Society's unrestricted funds totalled £538,334 which was an increase from the previous year's total of £432,177 by the amount of the surplus mentioned above. When added to the property revaluation reserve of £204,798 (unchanged from 2017) this brought the Balance Sheet total to £743,132.

It is the Society's practice to release funds as quickly as possible to support the provision of God's Word to people globally and here in Northern Ireland. Accordingly, it keeps reserves to a level considered broadly necessary to support operating costs over a twelve-month period. This has been documented in a Reserves Policy adopted by the Board during the year.

#### Key risks and uncertainties

The key risk and uncertainty that the Society faces is in relation to the level of voluntary income received. Future donations and legacies are not guaranteed, and their levels can vary greatly year on year. As voluntary income is the main source of funding for the Society, future activities are contingent on the levels received.

The Board of Trustees are satisfied that appropriate actions have been identified and taken so that this risk is managed effectively and on an ongoing basis through the introduction of a risk register.

#### Strategy for 2019 - 2021

During 2018 the Society has been preparing a new strategy for the next three-year period. Future strategy will continue to focus on supporting international Bible mission the United Bible Societies fellowship but also on increasing support for Bible engagement in Northern Ireland and raising the profile and awareness of the Society as a whole.

#### Conclusion

As in other years we can look back on 2018 as a year full of God's provision and blessing. We are grateful for our dedicated staff team and the members of our Board of Trustees for the time, energy and expertise invested over 2018 and also for our many supporters who have continued to commit to our mission statement of 'Reaching everyone with God's Word'.

# Trustees' Responsibilities Statement For the Year Ended 31 December 2018

The Trustees (who are also directors of The Bible Society in Northern Ireland for the purposes of company law) are responsible for preparing the Trustees' Report and the financial statements in accordance with applicable law and United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice).

Company law requires the Trustees to prepare financial statements for each financial year. Under company law the Trustees must not approve the financial statements unless they are satisfied that they give a true and fair view of the state of affairs of the charitable company and of the incoming resources and application of resources, including the income and expenditure, of the charitable company for that period. In preparing these financial statements, the Trustees are required to:

- select suitable accounting policies and then apply them consistently;
- observe the methods and principles of the Charities SORP;
- make judgments and accounting estimates that are reasonable and prudent;
- state whether applicable accounting standards have been followed, subject to any material departures disclosed and explained in the financial statements;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charitable company will continue in operation.

The Trustees are responsible for keeping adequate accounting records that are sufficient to show and explain the charitable company's transactions and disclose with reasonable accuracy at any time the financial position of the charitable company and enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the charitable company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

#### **Opinion**

We have audited the financial statements of The Bible Society in Northern Ireland (the 'charity') for the year ended 31 December 2018 set out on pages 13 to 24. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards, including Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' (United Kingdom Generally Accepted Accounting Practice).

In our opinion the financial statements:

- give a true and fair view of the state of the charity's affairs as at 31 December 2018 and of its incoming resources and application of resources, including its income and expenditure for the year then ended;
- have been properly prepared in accordance with United Kingdom Generally Accepted Accounting Practice; and

# Notes to the Financial Statements For the Year Ended 31 December 2018

#### 1. Accounting Policies

#### 1.1 Basis of preparation of financial statements

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015) - (Charities SORP (FRS 102)).

The Bible Society in Northern Ireland meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy.

#### 1.2 Tangible fixed assets and depreciation

A review for impairment of a fixed asset is carried out if events or changes in circumstances indicate that the carrying value of any fixed asset may not be recoverable. Shortfalls between the carrying value of fixed assets and their recoverable amounts are recognised as impairments. Impairment losses are recognised in the Statement of Financial Activities incorporating Income and Expenditure Account.

Tangible fixed assets are carried at costor valuation, net of depreciation and any provision for impairment. Depreciation is provided at rates calculated to write off the costor valuation of fixed assets, less their estimated residual value, over their expected useful lives on the following bases:

Freehold property - 2% Fixtures, fittings and equipment - 10 - 25%

#### 1.3 Stocks

Stocks are valued at the lower of cost and net realisable value after making due allowance for obsolete and slow-moving stocks. Cost includes all direct costs and an appropriate proportion of fixed and variable overheads.

#### 1.4 Income

All income is recognised once the company has entitlement to the income, it is probable that the income will be received and the amount of income receivable can be measured reliably.

#### 1.5 Operating leases

Rentals under operating leases are charged to the Statement of Financial Activities incorporating Income and Expenditure Account on a straight line basis over the lease term.

#### 1.6 Grants to United Bible Societies

Grants to the United Bible Societies are shown within Charitable Activities. These grants are made at the discretion of the Society for specific Scripture translation and distribution projects in various countries. The grants are recorded in the financial statements of the Society on an accruals basis as and when the amounts have been pledged.

## 1. Accounting Policies (continued)

#### 1.7 Other grants

Other international grants are awarded at the discretion of the Trustees. The authority to award grants not exceeding £12,500 has been delegated to the General Secretary. All grants are recorded in the financial statements of the Society on an accruals basis as and when the amounts have been agreed.

#### 1.8 Allocation of costs

Salaries are apportioned between costs of generating voluntary income, charitable activities and governance costs based on an estimate of the time spent by each member of staff on those activities. Other costs are allocated to the most appropriate heading.

#### 1.9 Pensions

The Society operates a defined contribution pension scheme and the pension charge represents the amounts payable by the Society to the fund in respect of the year.
